Recently, the Board of Directors from West Lauderdale Water Authority (WLWA) examined our current customer Leak Adjustment Program and addressed deficiencies found in the policy. The Boards findings concluded that our current "Leak Adjustment Policy" continued to place a burden on our customers even after an unexpected above average water bill had been resolved. In an effort to provide better service from WLWA, the Board of Directors voted to replace the current Leak Adjustment Policy.

Our new Leak Protection Program will be called WLWA-ServLine: giving our customers the flexibility to cover the cost of an unexpected high-water bill by participating in the WLWA-ServLine program. Customers may choose to decline participation in the program by calling our WLWA-ServLine customer service at (256) 740-3400 and have no additional charges attached to their water bill.

Non-participating customers will be responsible for 100% of their water usage.

A customer, who chooses to decline participation in our WLWA-ServLine Program, may re-enroll in our program after a 30 day wait period has concluded. Our WLWA-ServLine customer service representatives are here to assist with all the details of the new program.
